NOMINATION CRITERIA

SAFETY AWARD

Submissions must demonstrate how they improved overall safety of our industry or how they made an impact to correct or prevent a serious incident or injury from occurring. When judging this category, key accomplishments and attributes will be considered, including how the company has;

- Demonstrated leadership in safety and accident prevention within their organization
- Fostered innovation that lead to a safer workplace and railway industry
- Created technological advances that could have a positive impact on the industry as a whole
- Prevented a serious accident from happening that could have had catastrophic results

Submissions must satisfy one (1) of the above elements within the last 2 years.

INNOVATION AWARD

When judging this category, key accomplishments and attributes will be considered, including how the company has;

- The adoption of their technology has positively impacted the way organizations or industry is doing business.
- This impact is apparent through elements such as increases in efficiency, revenue and economic development.
- The innovation must have been tested and implemented for at least 12 months

DIVERSITY AWARD

Submissions must draw on building a culture of diversity and diversity of thought. Being able to leverage diversity of thought is key to creating an organizational culture of inclusion. When judging this category, key accomplishments and attributes will be considered, including how the company has;

- Demonstrated leadership in championing aspects of diversity within their organization
- Developed recruitment or retention strategies or campaigns that are being used by the nominated organization to engage diverse and under-represented groups
- Built internal communications and education campaigns and/or programs that promote diversity in the workplace
- Developed or supported policies supporting equal opportunities and how they are employed.

Submissions must satisfy one (1) of the above elements within the last 2 years.
